7 Line Diversion

This is to advise you of an upcoming service diversion affecting service on the 7 line between Corona and Flushing on weekends during the early Spring of 2011.

In order to carry out switch replacement work in the area of the Mets-Willets Point station, **there will be no 7 line subway service between the Mets-Willets Point and Main Street-Flushing stations between 4 a.m. on Saturday and 10 p.m. on Sunday on these weekends:**

March 19-20, 2011 April 2-3, 2011

March 26-27, 2011 April 16-17, 2011

April 30-May 1, 2011

Special *free* shuttle buses will operate between the Mets-Willets Point and Main Street-Flushing Stations on these weekends. Regular 7 line subway service will operate between the Mets-Willets Point and Times Square-42nd Street Stations while this work is underway.

We will post notices in all 7 line stations and make announcements on all trains informing customers of these temporary service changes. NYC Transit personnel will be on hand at the Mets-Willets Point and Main Street-Flushing Stations to assist our customers with any questions they may have and to expedite operations. Convenient "take ones" which explain the alternate services will also be made available for our customers.

Service notices will be posted on our website, www.mta.info; Notices will be printed in local newspapers prior to the commencement of the project.

We appreciate your community's patience and understanding while we carry out this important work.
