MEDALLION RENEWAL NOTICE

The New York City Taxi and Limousine Commission (TLC) hereby announces the following industry information specific to the renewal of all medallion taxicab owner licenses:

ALL TAXICAB LICENSES EXPIRE ON MAY 31

Pursuant to the TLC's Taxicab Owners Rules § 1-04(c) an original completed medallion renewal application, together with the required fee, and proof of insurance coverage are due to the TLC no later than May 31, 2004.

Medallions having the letters B, F, K or P will be required to pay a two year fee of \$1410.00 (2 years) which includes:

- \$1100.00 license renewal fee (\$550.00 x2);
- \$300.00 for six (6) Safety & Emissions inspections (\$150.00 x2);
- \$10 for a replacement tin.

All other licensees will be required to pay \$710.00 (1 year) which includes:

- \$550.00 license renewal fee;
- \$150.00 Safety & Emissions inspections and;
- \$10 for a replacement tin.

Please remit your payment promptly, but no later than May 28, 2004. You must complete the renewal process BY MAIL. You must attach to your renewal application a copy of the declaration page or Certificate of Liability for your insurance policy with an effective date of March 1, 2004 or later. Pertinent medallion number(s) must appear on each document. Fees for all 2-year renewals may be combined in one check and fees for all 1-year renewals may be combined in one check. However, fees for 2-year renewals are not to be combined in the same payment as fees for 1-year renewals.

Your payment must be in the form of a money order or certified check, made payable to: ***N.Y.C. Taxi & Limousine Commission.***

Late payments may result in the suspension of your license, the issuance of a summons and/or other penalties. Adherence to this due date will be strictly enforced.
